THIS IS THE LAST WILL AND TESTAMENT of me. JAMES ABRAHAM of Dundee, Natal, Gentleman.

I hereby revoke, cancel, annul and make void all Wills, Codicils and other Testamentary dispositions heretofore made or executed by me and I declare this to be my Last Will and Testament.

I give, devise and bequeath unto my sister MARION FLORENCE ABRAHAM, presently of 6, Fortfield Villas, Dartrey Road, Dublin, Ireland, FIVE HUNDRED (500) Shares in the Natal Navigation Collieries and Estate Company Limited, this legacy to be free from the control of any husband whom my said sister may at any time hereafter marry.

I give, devise and bequeath the whole of the remainder of my Estate and Effects, movable and immovable, personal and real, whether the same be in possession, reversion, remainder, expectancy or contingency, and wheresoever situate, nothing excepted unto MAURICE ABRAHAM and BRYAN ABRAHAM, whom I appoint Executors and Administrators of this my Will, but that in trust for the following ends, uses and purposes.

To pay all my just and lawful debts.

To sell and realise the whole or any portion of my Estate and Effects, as they in their discretion may think fit, to invest the proceeds derivable therefrom in such good and sufficient security as they may deem fit, and to pay the income, revenue and interest derivable therefrom unto my wife so long as she shall survive me.

On the death of my said wife, the whole of me Estate and Effects shall be divided equally between the nine children of the said marriage, the lawful issue of any deceased child to take that share which would have accrued to its parent if living.

It is my wish, desire and intention that my daughters shall not touch the Capital which is due to them, but shall only receive the income derivable therefrom, and such income

and capital shall be free from the control of any husband that any of my daughters have now or may hereafter have; and that after their death their share of the capital shall go to and devolve upon their lawful issue by marriage.
