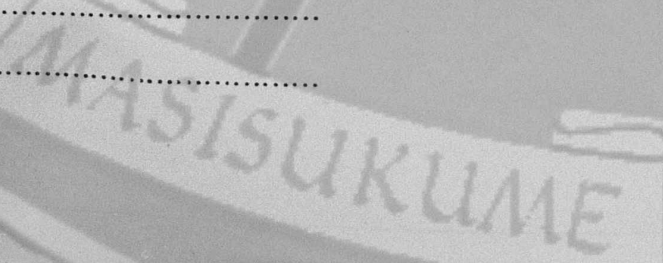

I give devise and bequeath the whole of my estate and effects movable and immovable and whether the same may be in possession, reversion, remainder or expectancy unto my said son ALEXANDER FRANK NOVELLI for his sole use and benefit.

I declare the foregoing to be my last will and testament desiring that it may have effect as such or as a codicil or otherwise as may be found to consist with law.

Dated at Pinetown aforesaid on this the sixteenth day of May in the year of our Lord one thousand nine hundred and twenty three in the presence of the undersigned witnesses.

N.B.—The law requires every Executor—

- (a) So soon as Letters of Administration have been granted to him, to make, subscribe, and transmit to the Master an inventory showing the value of all property belonging to the Estate (Section 44).
- (b) To cause notices to creditors and debtors to be published (Section 46).
- (c) To lodge with the Master a Liquidation and Distribution Account within six months after the date of his appointment. Every Executor who shall fail to do so without lawful and sufficient excuse shall forfeit all claim to any fees which he may otherwise have been entitled to and may be summoned before the Supreme Court to answer for his default [Sections 68, Sub-section (2), 69, Sub-section (3) and 100].
- (d) To open a special banking account so soon as he has funds of the Estate in hand over and above the amount of £20 (Section 116).

This therefore serves to inform you that the above provisions of the law will be strictly enforced.
